



Sponsorship & Exhibition Space contract between

On the one hand, **Middle East Energy Events FZ-LLC**, herein stated as "the **ORGANIZER**", a company established under the laws of the Emirate of Dubai with registered office in Dubai Studio City, Dubai, U.A.E., and license no. 91067. And on the other hand, the **SPONSOR/EXHIBITOR**, with details stated in 'Section A' herein stated as "the **SPONSOR/EXHIBITOR**", and declaring to have full legal capacity to sign this contract.

DECLARATIONS

The ORGANIZER is responsible for hosting and organising the MEPSC conference and exhibition that will take place in Manama, Bahrain from 09 - 11 October 2017, (hereafter, "the PROJECT").

- 1. THE SPONSOR/EXHIBITOR, within its participation and patronage activities, is interested in collaborating with the ORGANIZER.
- 2. By virtue of that previously declared, both parties mutually recognize their full capacity and powers to sign this exhibition/sponsorship contract, which is subject to the following:

ARTICLES

I. PURPOSE:

By virtue of the present contract, the ORGANIZER is committed to provide advertising services in benefit of the SPONSOR/EXHIBITOR as described in the third article thereafter, and the SPONSOR/EXHIBITOR is committed to support the PROJECT with the payment of the fee in the second article hereafter.

II. SPONSORSHIP/EXHIBITOR FEE:

The SPONSOR/EXHIBITOR undertakes to settle with the ORGANIZER the amount of US Dollars as referred in 'Section C/D and E' in favour of the ORGANIZER. This amount will be settled by means of a bank transfer of which the beneficiary is the ORGANIZER, as mentioned in 'Section E' herein.

III. ADVERTISING RIGHTS FOR SPONSORS ONLY:

None of the statements of this present contract surrenders any transmission of copyright or intellectual ownership of the SPONSOR/EXHIBITOR.

VI. DURATION

The present contract will come into effect on the day of its signature and will maintain its validity until 11 October, 2017, the same date as **the PROJECT** is due to be concluded, as is expressed in declaration of this contract. Nevertheless, if for any reason **the PROJECT** has not concluded on that date, this contract will maintain its validity until the end of all official acts of **the PROJECT**.
